Together, we continue to forge a strong academic legacy for St. Xavier's University, Kolkata.




Category-Wise Number of Publications

Fr. Eugène Lafont, S.J. (1837–1908) was a Belgian Jesuit priest, scientist, and educator, widely regarded as the Father of Modern Science in India. He came to Kolkata in 1865 and dedicated his life to teaching at St. Xavier's College, where he established one of the country's first scientific laboratories. A visionary teacher, he introduced experimental science into Indian education and inspired generations of students, including Sir Jagadish Chandra Bose. Through his pioneering work, Fr. Lafont not only advanced scientific learning but also nurtured a spirit of inquiry, leaving a lasting legacy in the fields of education and research in India.
