## Paper Submission Guidelines

- Soft copy of the paper should be submitted. The text of the paper will be in Times New Roman, Font size 12, double space and keeping a margin of one inch in three sides. MS Word (.doc format) is required. Each paper should be preferably within 5000 words including tables and references, in addition, an abstract of not more than 500 words in a separate page.
- There should be a separate title page on each paper giving details of author/s, affiliation, address, telephone numbers and e-mail.
- Abstract is required to be submitted first. An abstract is a single paragraph, without subheadings, indentation or references. It should be an explicit summary of your presentation that states the problem, the objectives, the methods used, and the major results and conclusions. It should be single-spaced in 11-point Times New Roman. Do not include bullets/lists or references in the abstract. Title should be given at top of the page and the details of the authors with affiliation and email should be given thereafter.
- Paper presentation will take place in concurrent sessions and abstract of each accepted paper will be published in the Conference Proceedings.
