

## **Departmental Events**

- 1. Intra-Departmental Debate Competition on August 30th, 2024 Organised by XAVECOS, the Economics Society of SXUK, this debate encouraged students to articulate and defend their views on contemporary economic and social issues, sharpening their analytical and public speaking skills.
- 2.5th Annual Economics Summit on February 20th, 2025 A flagship student-led event bringing together scholars, professionals, and students to engage in interactive discussions on pressing economic issues and industry trends. This was followed by the 3rd Annual Economics Conference on February 21st-22nd, 2025 A two-day academic conference that featured paper presentations, panel discussions, and research dialogues across diverse economic domains. It provided a professional platform for students to present their research and engage with faculty and external experts.
- 3. Field Survey to Shantiniketan (Bolpur, West Bengal) on January 2025 A field-based primary research project focusing on occupational mobility in rural areas of Shantiniketan. This initiative involved direct interaction with local communities, data collection, and analysis, offering students real-world exposure to rural economic dynamics.
- 4. Guest Lecture by Dr. Joseph Flavian Gomes on January 30th, 2025 Topic: "Cognitive Consequences of Insecure National Belonging". A thought-provoking session exploring the intersection of identity, social cohesion, and economic behaviour.
- 5. Placement Talk by Mr. Indranth Mukherjee on May 27th, 2025 An interactive session on navigating the professional world, building a career in economics, and strategies for excelling in corporate recruitment processes.
